## **Objectives and investment policy**

#### Objective

The fund aims to provide long term capital growth.

#### **Investment Policy**

The fund invests in a diverse portfolio of assets, including collective investment schemes, company shares, structured products which themselves invest in derivatives (for both investment and/or to manage the risk profile of the fund), deposits, cash and/or near cash and investment trusts which may invest in shares and alternative asset classes such as hedge funds, structured products, infrastructure, property and private equity funds.

#### Essential features of the fund:

 The fund has the discretion to invest in the investments as described above with no need to adhere to a particular benchmark.

- You can buy and sell shares in the fund each business day.
- The fund aims to distribute available income every six months.
- Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

## Risk and reward profile



- This indicator shows how much a fund has risen and fallen in the past, and therefore how much a fund's returns have varied. It is a measure of a fund's volatility. The higher a fund's past volatility the higher the number on the scale and the greater the risk that investors in that fund may have made losses as well as gains. The lowest number on the scale does not mean that a fund is risk free.
- The fund has been classed as 3 because its volatility has been measured as medium to average.

- Non-UCITS Retail Scheme (NURS): The fund can be less diversified than UCITS schemes as it has higher investment limits for certain types of assets. It can also invest in assets which are not available to UCITS schemes. This can increase the potential rewards but can also increase risk.


The entry charge shown is a maximum figure. In some cases investors may pay less. You can find out the actual charges from your financial advisor or distributor.
